COVID-19 Prevention:

- National Ski Associations are responsible for leaving sick individuals at home. Anyone who shows symptoms of COVID-19, like upper respiratory tract symptoms (fever, a sore throat and coughing) or lack of smell and taste, should not enter the United States.
- **All athletes and staff should have a negative test within 72 hours before flying to the United States.**
- Under current regulations **individuals are NOT required to undergo testing or to quarantine** when entering Utah.
 - Testing immediately after entering Utah is available for teams who request it.
 - All COVID-19-tests will be provided by local health authorities, and the cost of these test must be paid by all nations (together with all other costs and reimbursement).
 - **Positive Test:**
 - If the test confirms that you have COVID-19, you will be contacted and monitored by the health services. To avoid transferring the disease to others and stop the spread, you will need to stay in isolation.
- All athletes and support personnel are strongly recommended to stay in the accommodations offered by the OC. If a person or team arrives from outside of Utah wants to stay outside of the OC-hotels, this must be applied for and approved by the OC within three weeks before official opening date.
- All COC teams will be located in the same section of the hotel to avoid interaction with non-competition individuals
- Meals will be separate from non-competition individuals

Routines during your stay in Utah:

- Group size should not exceed 10 people
- Face masks are required under the existing Face Covering Ordinance in Summit County. <https://summitcountyhealth.org/public-announcements/10-22-20-summit-county-high-risk/>
 - Where masks whenever possible. A face mask can serve as a measure for infection control in situations where the risk of infection is increased or high
- Wash hands frequently and thoroughly with soap and lukewarm water.
- Use an alcohol-based disinfectant if soap and water is not available. Especially when you have been in contact with other people
- Keep a distance of at least 1.5 meters to others
- Avoid coughing or sneezing directly onto others
- Find alternatives to shaking hands and hugging

COMPETITION RULES:

FIS ICR Rules will apply. Athletes must have a valid FIS License.

TRANSPORTATION:

Each Nation should make their own airline and ground transportation arrangements. Your team should make arrangements to fly to (SLC) Salt Lake City, UT. We recommend you rent a van from the airport and plan for a 40-minute drive or 60km to Park City, UT via I-80.

Transportation to and from the airport in Salt Lake City can be arranged if requested but it would require reservation of complete vehicle to avoid interaction with outside individuals. Please email Info@usanordic.org to schedule transportation at least 10 days in advance.

Due to COVID-19 all teams will be required to rent their own vehicles for transportation.

INSURANCE:

All competitors are to be insured by their own Ski Association

DOPING POLICIES AND PROCEDURES:

The FIS is committed to maintaining the integrity of all ski competitions. In order to prevent the use of forbidden substances or methods, doping controls can be carried out at any FIS sanctioned event.

COMPETITION OFFICE and ACCREDITATION

The Competition Office will be located at the USANS Office located at 3419 Olympic Parkway, Park City, UT 84098. Upon arrival all team leaders must report to the competition office for check-in and accreditation. Team check-in must be completed before using the competition venue. A map and location will be provided before arrival.

Officials and judges travel reimbursement will be taken care of following the Team Captains Meeting on 10th
